Indian Institute of Forest Management, Bhopal, an autonomous Institute of the Ministry of Environment & Forests, Govt. of India, is engaged in education, training, research and consultancy needs of the forestry and allied sectors. The Institute is in need of the services of Four suitable Indian Forest Service (IFS) Officers for appointment on deputation as Faculty.

**Faculty positions (Asstt. Professor/ Associate Professor/Professor) (4 Positions)** in the area of **(i) Climate Change (ii) Eco-system & Forest Land Restoration (iii) Eco-tourism (iv) Forestry Policy & Law, (v) Sustainable Forest Management (vi) CDM/Carbon Trading.**

**Qualifications & Experience for faculty positions :**

**Eligibility:**

- A) Desirable qualification: An outstanding officer who have earned reputation for the field innovations, extensive field experience and Ph.D. degree. The person who has made significant contributions to knowledge demonstrated by academic publications but not having Ph.D. degree may also be considered.
- B) Appointment of IFS officers on deputation to IIFM in the scale of Rs.12000-420-18300 (corresponding to Deputy Conservator of Forests/Assistant Professor).

Eligibility: The IFS officers, who have completed 9 years of service, shall be eligible for appointment in the scale of Rs.12000-420-18,300.

- C) Appointment of IFS officers on deputation to IIFM in the scale of Rs.16400-450-20000. (corresponding to Conservator of Forests/Associate Professor).

Eligibility: The IFS officers, who have completed 14 years of service, shall be eligible for appointment in the scale of Rs.16400-450-20000.

- D) Appointment of IFS officers on deputation to IIFM in the scale of Rs.18400-500-22400 (corresponding to Chief Conservator of Forests/ Professor).

Eligibility: The IFS officers, who have completed 18 years of service, shall be eligible for appointment in the scale of Rs. 18400-500-22400.

Candidates fulfilling the above qualifications and experience may submit their application in the prescribed format through proper channel with a request to forward the application to the Director, IIFM, Bhopal with (a) ACRs of preceding five years and (b) State Vigilance Clearance certificates of the officers. The Institute shall short-list the candidates in the appropriate faculty positions based on their qualifications and experience.

The period of deputation for the above mentioned posts will be 05 years for CCF and CF scale and 04 years for Dy.CF scale which can be further extended as per the MoEF, GOI instructions on the subject.

The Institute reserves the right to fill up or not to fill up any or all the posts or to shortlist and select the candidates in any suitable position as above.
